The *Alliance High School (AHS) Foundation* has implemented a policy which permits specific recognition of individual "named" scholarships for endowments with a minimum of \$25,000. The *AHS Foundation* will review all applications for named scholarships and have the final decision regarding acceptance or rejection in its sole discretion. If said scholarship is accepted, the *AHS Foundation Board of Trustees* will solely determine all handling of all principal, interest, accumulation or growth of the scholarship fund, and the award of the scholarship. Investment, distribution, accumulation, award and all other matters regarding management of each scholarship shall remain under the sole discretion of the *AHS Foundation Board of Trustees*.

The selection of student(s) receiving awards for a named scholarship shall be made by the *Board of Trustees of the AHS Foundation*, who may consult with the guidance counselor(s) at Alliance High School. The *Board of Trustees* may consider the criteria of the named scholarship outlined when the named scholarship was initially established by the Donor.
